Article 1: Hosting Agreement

=====

Payment for rental hosting EasyGiga SA signifies acceptance of Terms

Article 2: Duration of contract

=====

The hosting contract is concluded for a period of 1 year. It ends at or customer intends to terminate it. For partners, resellers, or any other agreement different oral or written with a collaborator EasyGiga SA is subject to a minimum, termination of 6 months to save the one hand the interests of the partner, or other resellers, and other those EasyGiga SA for costs arising from the investment partnership. Domain names are ordered and paid for valid 1 year and can not be be no refund for any reasons. The client wishes to cancel a domain name must announce it by registered letter at least 30 days before its expiry. If this deadline is not met, he will perform it for another year.

The customer does not pay the amount due in time for its domain name, the day after his Expiration:

Article 4: Transfer Domain Name

Article 5: Payment of bills
